



Liability Waiver for Family Reversion Yoga

I understand and expressly agree that my use of the BurnCraft Fitness facility or participation in BurnCraft Fitness on-site and off-site services, including Reversion Yoga, involves the risk of injury to me and/or my child whether caused by me or not. I understand that these risks are inherent in physical activity and can range from minor injuries to major injuries, including death. I understand and voluntarily accept full responsibility on my and/or my child's behalf for the risk of injury or loss arising out of or related to my and/or my child's use of the facility or participation in BurnCraft Fitness classes.

I further agree that BurnCraft Fitness LLC, its agents, directors, employees, managers, members, landlords, and independent contractors will not be liable for any injury including, without limitation, personal, bodily, or mental injury, disability, death, economic loss or any damage to me, my child, my spouse or domestic partner, guests, unborn child, heirs, or relatives resulting from the negligent conduct or omission by BurnCraft Fitness LLC or anyone acting on their behalf, whether related to exercise or not.

I affirm that my child and I are in good physical condition and have no medical reason or impairment that might prevent us from our intended use of BurnCraft Fitness' facility. I acknowledge that BurnCraft Fitness strongly encourages all its clients, members, and participants to obtain a physical examination and clearance from a physician before starting any exercise or nutrition program or participating in any of its group fitness classes, any of its challenges and programs, or any special events and fitness/nutrition seminars. I acknowledge that if I have any health or medical concerns now or after I start my and my child's training at BurnCraft Fitness, it is my responsibility to discuss them with my doctor before using the facility and/or engaging in the BurnCraft Fitness services.

I agree that I am responsible for the care, safety, whereabouts, and actions of my accompanying minors and/or my guests inside and in the immediate vicinity of the BurnCraft Fitness facility, including but not limited to the parking lot.

To the fullest extent permitted by law, I do hereby forever release, waive and discharge BurnCraft Fitness LLC from any and all claims, demands, injuries, damages, actions or causes of action related to my and my child's use of the facility (collectively, "Claims") against BurnCraft Fitness LLC or anyone acting on their behalf, and hereby agree to defend, indemnify and hold harmless BurnCraft Fitness LLC from and against any such Claims.

I further understand and acknowledge that BurnCraft Fitness LLC does not manufacture fitness or other equipment or products available in its facility and therefore BurnCraft Fitness will not be held liable for defective equipment or products.

By participating in its classes and services, I give BurnCraft Fitness authorization to post and tag (with my full name) photos and videos containing my and my child's image on their website, Facebook, YouTube, Instagram, and other social media as well as in print and video for promotional and marketing purposes.
